5 Issues to Watch in the Supreme Court This Year

It's obvious, but it's easy to forget: Courts matter. Federal courts determine the scope of workers' rights and the constitutionality of civil rights laws. The U.S. Supreme Court is the final stop when it comes to many of the most important legal challenges our country faces. Here's a summary of what to expect as the Supreme Court's term gets underway.

1. Fallout from Burwell v. Hobby Lobby

In this past summer's disappointing *Burwell v. Hobby Lobby* decision, the Supreme Court ruled that closely held corporations can't be required to cover contraception through their employee health insurance plans. Despite Justice Alito's assurance that the *Hobby Lobby* ruling would have limited reach, fallout from the decision could seriously threaten many more employees' access to preventative health care. The first *Hobby Lobby* fallout on the horizon concerns religiously affiliated nonprofits.

2. Restricting Choice: TRAP Laws

In the last few years, a number of states across the country have passed so-called TRAP laws in an attempt to restrict and even eliminate women's access to legal abortion. TRAP stands for Targeted Regulation of Abortion Providers. While many antichoice laws impose restrictions on patients, TRAP laws are designed to prevent doctors from performing abortions altogether. TRAP laws are passed under the guise of protecting women's health, even though the provisions generally do nothing to increase the standard of care — the laws only make it more difficult for women to find good reproductive health care.

3. Pregnancy Discrimination: Young v. UPS

Peggy Young, a UPS driver, requested temporary light-duty work because of medical complications during her pregnancy. UPS refused to provide light-duty work, even though it allowed several other categories of workers to be assigned such work when they were temporarily disabled. Because UPS refused to accommodate her restriction, Young was forced to leave her job, losing her income and health care coverage at a critical time. Young eventually sued UPS under the Pregnancy Discrimination Act. Unfortunately, both the federal district court and the Court of Appeals for the 4th Circuit sided with UPS. If the Supreme Court sides with UPS, it could leave pregnant workers vulnerable to discrimination in the workplace.

4. Voting Rights at Risk

Voters in nearly half the country in our recent election were expected to face new voting restrictions at the polls — restrictions that weren't there during the last midterm election four years ago. These voting restrictions hurt women, minorities, young voters, and the elderly the most. The Voting Rights Act of 1965 was supposed to stop states from passing these kinds of voting restrictions. But the court's 2013 decision in *Shelby County v. Holder* weakened the law, gutting the spirit but leaving the name.

5. Marriage Equality Surging

In the best news of the new term, marriage equality is increasing across the country as one same-sex marriage ban after another is struck down. All but one federal judge to consider the question have ruled that same-sex marriage bans are unconstitutional. Several states whose bans had been rejected by lower courts asked the Supreme Court to review their cases. So far, the court has declined to hear any of the cases, making marriage equality a reality in many states. In a year with so many high-stake cases, it's exciting to tally the marriage equality victories we've won so far. But much is left to be decided, and the court's term is far from over.

10 States Doing Excellent Work on Ballot Initiatives

AAUW-Supported Ballot Initiatives Win in Several States

On Election Day, AAUW's and friends' voices were heard loud and clear on ballot initiatives, thanks in large part to the hard work of AAUW members and leaders in these states. All of the AAUW-supported minimum wage referendums on the ballot passed by significant margins in Alaska, Arkansas, Nebraska, and South Dakota, plus a non-binding measure passed in Illinois. Voters defeated personhood amendments in Colorado and North Dakota, but unfortunately a Tennessee ballot initiative was approved that will give state lawmakers more power to restrict and regulate abortion. Oregon passed a state version of the Equal Rights Amendment, and voters in Massachusetts, Oakland (CA), and Montclair and Trenton (NJ) passed ballot initiatives guaranteeing paid sick days to more workers. These results will positively affect women and families nationwide, we hope they encourage branches to expand state and municipal advocacy efforts.

ADVOCACY COMMITTEE

On November 1, the North Peninsula Branch invited our Representative, Congresswoman Jackie Speier, to speak to members of AAUW about issues that we support. It was a very interesting discussion including her push to remove the deadline on the Equal Rights Amendment (ERA) of the U.S. Constitution. If the deadline is removed, only 3 more states need to ratify it for it to become a constitutional amendment. Another issue she brought forward is the large numbers of sexual assault and rape in the military and on college campuses that are not being investigated properly. A third is the wealth inequality in the United States. She suggested ways that this could be addressed including: raising the minimum wage; paid sick leave and family and medical leaves; and quality, affordable day care for working parents.

In order for the San Mateo Branch to be more involved in our mission of advocating for women and girls, we would like to form an Advocacy Committee. This committee would consist of a chairperson and two or three other members who would look into the issues presented by AAUW CA National well and AAUW as Representatives to determine if there is any action our branch can take. These actions might be sending letters to our state Senator and Assemblyman Congressional and our Representative and Senators; following AAUW CA and National "two-minute activist" suggestions and bringing them to the membership among other activities. If you're interested in advocacy, this could be a good opportunity for you to become involved. It would not involve a lot of time, and the committee could set its own agenda. Black-Eyed Pea Salad (10 servings)

2 C. dried black-eyed peas, rinsed and picked over

2 T. celery salt

1/2 C. olive oil

1/2 C. balsamic vinegar

1 T. plus 1 t. stone-ground mustard

1/2 C. small-dice red onion

1/2 C. medium-dice red pepper

1 C. medium-dice celery

1/2 C. finely chopped fresh Italian parsley

2 T. kosher salt

1 t. freshly ground black pepper

Combine peas and celery salt in medium pot. Add water to cover by 2 inches and bring to a boil. Reduce heat and simmer until peas are soft but not mushy, 30 minutes to 1.5 hours. Drain and cool.

In a large bowl, whisk together oil, vinegar and mustard. Stir in the onion, red pepper, celery, parsley, salt and pepper. Add the drained peas and toss to combine. Taste and adjust seasonings if necessary.
