Advocacy: Action not Apathy

Advocacy is a way of instituting change in society. Apathy is an attitude that accepts the status quo. Advocacy tries to change the "what is" to "what should be". And because you are members of AAUW, you have already made the choice that apathy is unacceptable and that advocacy must be our course of action.

We are on the side of advocacy by belonging to an organization that is empowering women and girls in a variety of ways. AAUW/San Mateo has been active in supporting the education of women and young girls through our support of Tech Trek for middle school girls, academic scholarships and, most recently, leadership development for women through a national conference for this purpose.

But there is much more that the needs of the time call upon us to do and that we can do. We do not need to march, sit-in, knock on doors or circulate petitions personally. Although all of these are good and helpful activities. The national offices of AAUW have made it possible to accomplish much while doing something simple and well within our scope.

We can go to our computers, read the action calls sent to all registered members, scroll to the bottom of the page and just click. It is that simple.

By clicking on the box marked "submit," we can add our names and numbers to support work that is still not completed: equal pay; ending sexual trafficking; the Equal Rights Amendment--so many issues that AAUW is monitoring and asking us to be informed about and to support through advocacy and action.

AAUW and Title IX

Most people think Title IX only applies to sports, but athletics is only one of ten key areas addressed by the law. These areas include: access to higher education, career education, education for pregnant and parenting students, employment, learning environment, math and science, sexual harassment, standardized testing, and technology. ¹

The law states: "No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance."

It's hard to imagine that just forty years ago, young women were not admitted into many colleges and universities, athletic scholarships were rare, and math and science was a realm reserved for boys. Girls square danced instead of playing sports, studied home economics instead of training for "male-oriented" (read: higherpaying) trades. Girls could become teachers and nurses, but not doctors or principals; women rarely were awarded tenure and even more rarely appointed college presidents. There was no such thing as sexual harassment because "boys will be boys," after all, and if a student got pregnant, formal education ended. professional schools openly discriminated against women.2

Title IX applies to anyone who is being discriminated against: boys or girls, men or women, gay, lesbian or transgender. Progress has been made in the past 40 years but it is an ongoing battle. The rape and sexual assault cases on many American colleges and universities campuses have been brought to the attention of the college and university administrators under Title IX.

AAUW members do amazing work to ensure that Title IX is enforced. They investigate compliance, assemble lists of Title IX coordinators, promote better anti-sexual-assault policies, and help teach students, parents, educators, coaches, and administrators about Title IX's requirements. The

U.S. Department of Education simply cannot enforce Title IX alone, and AAUW's work goes a long way toward making schools and sports fairer for women and girls. We all need to be vigilant in observing and reporting cases of discrimination that fall under the Title IX umbrella.
