Known best for its pink theme color, the month features a number of campaigns and programs designed to support people diagnosed with breast cancer, including those with metastatic breast cancer; educate people about breast cancer risk factors; encourage women to go for regular breast cancer screens; and raise money for breast cancer research. If you haven't had a screening recently, ask your doctor if you should have one. Mammograms are the best way to detect early stages of breast cancer.

Since school has begun again, this is the perfect time to inform you of an AAUW CA public policy program called the School Board Project. This is an ongoing project with the goal of protecting the freedom of states to decide their own curriculum and protect schools' ability to teach honest history. We can help with this effort by ensuring the candidates for local school boards understand their responsibility to educate our students in all aspects of our country, good or bad. Please monitor your local school board elections to know the candidates and their opinions about their responsibilities to protect teachers and students from the dumbing down of education. October General Meeting California Proposition 50 and The Myths and Facts of the Electoral College

The October general meeting will discuss two areas of voters' interests: the myths and facts of the Electoral College and California Proposition 50 which will be on the November 2025 ballot. This discussion will be led by Gayle Hardt, a retired attorney and a member of the San Mateo Branch of AAUW and the League of Women Voters of North and Central San Mateo County.

California Proposition 50

Proposition 50 replaces California's current congressional district maps with new, legislatively drawn maps. (The total number of districts would not change.) Proposition 50's maps must follow federal law, but they are not required to follow the state requirements placed on the Commission. The state would use Proposition 50's maps for congressional elections starting in 2026. The state would use these maps until the Commission draws new district maps, following the 2030 U.S. Census.

Proposition 50 also asks the U.S. Congress to change federal law and propose an amendment to the U.S. Constitution to require redistricting be done by "fair, independent, and nonpartisan redistricting commissions nationwide." Proposition 50 does not change federal law or require any particular action of Congress or the California Legislature. Please join us to hear about these topics and have your questions answered to the best of our ability.

The Electoral College

The Electoral College is a process for electing the President and Vice President of the United States. The Founding Fathers established it in the Constitution, in part, as a compromise between the election of the President by a vote in Congress and election of the President by a popular vote of qualified citizens. Each state appoints as many electors as it has senators and representatives in Congress. The District of Columbia has no senator or representative, but they are given three electors as provided in the 23rd Amendment. A candidate must win 270 of the 538 votes to win the election.

Over the years it has been proven that the Electoral College does not reflect any coherent political theory, but flows instead from deals the delegates had made in response to the specific conflicts they faced at a particular moment in history.

Public Policy AAUW CA, The School Board Project

The constant noises that surround us today has had the effect on many of us wanting to "shut the door" and withdraw behind a protective shield. This is not an option if we want to protect our democracy and the rights declared in our Constitution.

The role of education is one giving "every citizen the information he needs...to understand his duties to his neighbors and country...to know his rights". It is not to deny history or provide political propaganda.

We must continue to protest national policies that threaten our basic core principles and take a stand at the state and local levels. AAUW California's mission and public policies are being threatened, and we will not stand by and allow this to happen.

These hard-fought gains are under attack, and it begins with local elections for school board members. Organizations with money are backing candidates who are attempting to restrict student rights and censure the curriculum and books available that would provide factual, open discourse. These efforts will create a generation of children exposed to limited information and unprepared to engage in critical thinking necessary to fully realize the American experiment in democracy, which is the exact opposite effect from the intentions of our forebears.

Please look for future information that will describe how the Public Policy School Board Project is fighting back and how you can be a part of this policy.

A Big Win for Public Education

On August 14, 2025, a federal judge delivered a major legal victory for public education and civil rights. In American Federation of Teachers et al. v. U.S. Department of Education et al., the court struck down the Trump-Vance administration's attempt to force schools nationwide to censor lessons, eliminate diversity and inclusion programs, and sign unlawful compliance certifications under threat of losing federal funding and facing criminal penalties.

Judge Stephanie A. Gallagher ruled that both the administration's February 14 "Dear Colleague Letter" and its mandatory certification violated the Constitution and the Administrative Procedures Act (APA), stating: "Plaintiffs have shown that neither challenged agency action was promulgated in accordance with the procedural requirements of the APA, and that both actions run afoul of important constitutional rights."

This decision vacates both policies, thereby, protecting the ability of educators to teach honest history, support students, and foster inclusive learning environments.
